Type of examination	<p>The master's thesis is assessed on the basis of the master's thesis itself and an oral examination based on the master's thesis.</p> <p>The oral examination is an individual examination for students who have prepared their master's thesis either alone or for those who have requested an individual examination. The other oral master's thesis examinations are held as group examinations. The examination will be based on the entirety of the master's thesis. The student(s) start(s) the examination with a short presentation, after which the examination is conducted as a dialogue between the student(s), examiner and external examiner. During the examination, questions can be posed that relate to the subject area(s) that the master's thesis covers. There is an individual assessment of each student's performance.</p>

The assessment is an overall assessment of the master's thesis and the oral presentation.

The groups may consist of 2 to 4 students. The size specifications for the master's thesis are:

For 1 student a minimum of 122,400 and a maximum of 163,200 number of characters incl. Spaces.

For 2 students, a minimum of 163,200 and a maximum of 204,000 characters, including spaces.

For 3 student a minimum of 163,200 and a maximum of 204,000 number of characters incl. spaces.

For 4 students, a minimum of 163,200 and a maximum of 204,000 characters, including spaces.

The size specifications include the title page, table of contents, bibliography, figures, and other illustrations, but does not include any potential appendixes or annexes. The master's thesis must include an abstract. Master's theses written in Danish, Norwegian or Swedish must be provided with an abstract in English. Master's theses written in a foreign language (except Swedish and Norwegian) can be provided with an abstract in Danish. The abstract is included in the overall assessment with a weighting of 5 percent.

Time allowed for examination, including time used for assessment:

For 1 student - 30 minutes.

For groups of 2 students - 60 minutes.

For groups of 3 students - 75 minutes.

For groups of 4 students - 90 minutes.

(For 60 ECTS master's theses, the examination times are doubled). The assessment includes the quality of the spelling and ability to express oneself in the project report and this is weighted at 10%.

Permitted support and preparation materials during the examination: All.

Assessment: 7-point grading scale.

Moderation: External.

The master thesis is written on a topic within the programme's subject area, which includes businesses' development, organisation, management, innovation, resources and value creation as well as the world around them.

The master thesis is written in the programme's teaching and examination language. The Head of Studies must approve the master thesis outline.

Teaching and working methods

The student must attach a description of the course of his/her studies which must include an explanation of the student's development and insights based on how the project work has been completed throughout the whole or parts of the programme.

The students under this study regulation can write their master thesis together with students writing the master thesis for Business Studies.
