Students who were admitted before 1. September 2022 must finish their programme with the following modifications:

**Second semester** Students who have not passed Foundation course in Global Studies (10 ECTS) must instead follow Foundation Course in Global and Development Studies (10 ECTS).

**Third Semester** Students who have not passed Elective course: Advanced study course (10 ECTS) must instead follow Current Global and Development Challenges and Solutions (10 ECTS).
