| Overall objective | <p>A specialisation course aims to allow students to immerse themselves in the theories/theory lines and empirical issues pertaining to a particular subject area. The course equips students to competently select and argue for the applicability and relevance of a theory/theory line to given issues. The courses offered are based on the Institute's research in the field and knowledge of the highest international standard. The specific subject area of the courses will be described in the activity description.</p> <p>Advanced Study Seminars offers students insight for instance into how international politics impacts governance, how governance impacts politics, and what this means for the ability of international institutions, governments, and other organizations to help address current issues such as climate, environment, security, digitalization, and public health.</p> |
| Detailed description of content | <p>International politics has traditionally been analysed from inter-state perspectives. Since international organisations emerged, these have become important tools of great powers, arenas for state actors to cooperate, and even norm-generating agencies that can change states' behaviour. These institutions also exist at regional level, most prominently in Europe. In this course we focus particularly on the EU's (European Union) external relations and the interconnections with other world regions, and regional and global institutions. These constitute a crucial element to supplement the study of inter-regionalism and multilateralism. International politics and multilevel governance require a multi-layered toolset for which regional and inter-regional settings are essential as competences in important policy areas have often moved either upwards (to a supranational region) or downwards (to a subnational group) or are part of shared competences that may be difficult to identify from the outside. Key course topics include 'the EU in international politics', EU's relationship with the near abroad and with other regions of the world. Also, the course looks into how the EU and other actors work with transnational non-state actors and major states globally.</p> |

| Overall plan and expected work effort | <p>The course consists of lectures, but students are expected to actively participate by asking questions and contribute to class discussions</p> <p>Preparation:</p> <p>As part of the course, the student is expected to prepare for classes by reading assigned texts for the given session. Teachers in turn pledge to make use of the students' preparation in the teaching.</p> <p>The course is 10 ECTS, so approximately total 275 hours. Weekly estimated workload is approximately 17 hours (2 hours of presence and 15 hours preparation) for the 13 weeks of classes (17*13=221 hours).</p> <p>Expect around 50 hours of preparation for the exam</p> |
